#### EVALUATION CONCLUSIONS AND RECOMMENDATIONS

#### Support and innovation measures

The use of the standard unit cost option is encouraged (as well as the adoption of new solutions for monitoring training courses).

#### Investment measures

It is recommended, among other things, to eliminate the requirement for beneficiaries to submit negations issued by public institutions, delaying the submission of certain opinions and the reduction of the number of supporting documents requested to beneficiaries and issued by public authorities.

Measures with flat-rate support

It is recommended to avoid re-checking during the pre-contracting stage the documents submitted during the submission stage.

Measures with standard unit costs

It is recommended to modify the procedural flow by carrying out the over-control independently and simultaneously with the verifications carried out by other institutions involved.

#### **Compensatory measures**

It is advisable to avoid double checking done by different institutions involved in implementation.

#### Leader measure

It is recommended to delegate to AFRI the process of approving the evaluation fiches, guidelines and methodologies developed by LAGs in the cases of atypical measures in LDSs and adopting the simplified cost option.

The National Rural Development Program (NRDP) is a financial instrument with a financial allocation of 9.441.583.798 Euro, through which non-refundable grants from the European Union and from the Romanian Government are provided for agriculture and rural development.

From the experience gained during the previous programming period (2007-2013), it can be noticed that the administrative burden and costs having an impact on both beneficiaries and NRDP managing authorities can affect the attractiveness of the various sub-measures and the progress in achieving the objectives of the program strategy. In this context and by adopting the objective to simplify the program and the procedural documents (while also taking into account the future programming period), the Managing Authority has considered the necessity of an impact assessment of overregulation on the implementation of the NRDP 2014-2020.

#### THE PURPOSE OF THE EVALUATION STUDY

The aim of the study was to identify the requirements and legal provisions that can be considered elements of overregulation in the implementation of the NRDP, as well as submitting simplification proposals, relevant as well for the next programming period while also assessing the impact of the actions proposed in the 2014-2020 NRDP to reduce administrative burden.

#### **EVALUATION RESULTS**

The impact of the overregulation on the implementation of the NRDP 2014-2020 is assessed as being relatively low, the procedures applicable to the different sub-measures being largely based on the respective national EU legislation or justified by the principles of transparency, regularity and sound financial management.



Furthermore, the measures introduced at the level of this implementation period (2014-2020) towards simplifying implementation have positively influenced:

- the application phase (by reducing the number of required supporting documents or by delaying the stage at which the documents must be submitted);
- the selection process (which allowed qualitative selection of projects over a shorter period);
- the project implementation process (e.g. by introducing the standard unit costs option, standardized procurement fiches, etc.).

The impact of these simplification actions of a transversal nature can be further extended to other measures and sub-measures in order to continuously improve the manner in which the programme is implemented.

# Annex 1. Benchmark analysis

# Introduction

Of the 118 Rural Development Programmes (RDPs) for the 2014-2020 programming period<sup>1</sup>, it was considered appropriate to carry out a comparative analysis of the Irish<sup>2</sup> National Rural Development Programme and Regional Rural Development Plans in Veneto<sup>3</sup>, Aragon<sup>4</sup> and Tuscany<sup>5</sup>.

The selection justification for performing the benchmarking analysis of the Irish National Rural Development Programme is that it has the highest rate of access to EU funds, compared to the RDP 2014-2020 from other Member States (see Annex 1.1), with an absorption rate of 56%. Veneto Regional Rural Development Plan was selected taking into account the expenditure absorption rate of 41,9% (the second highest rate in Italy regions), but also for its particular relevance given the viability and competitiveness of the planned expenditure, while in Ireland there is a high incidence of planned resources for environmental priorities.

The choice of Aragon region has a similar justification because it has one of the highest spending rates in Spain and a significant rate of access to EU funds. While the Tuscany region has been selected because it pays special attention to rural development, it has extensive experience in rural tourism and has recently implemented the standard cost<sup>6</sup>.



NRDP Ireland has been selected for analysis because it has a significant programme-level experience on LEADER approach, which has been part of rural development policy since the early 1990s, at the same time being noticed the significant effort to highlight farmers' rights (the "Farmer Chart"), as well as the use of an attractive application format under the different schemes. The two regions of Italy have been selected for analysis for various reasons, including for the degree of planning and accessing European funds in Italy (over 20 million euro - for more details see Annex 1.1) or the relevant experience in the administrative simplification process (started in 2010).

At the same time, the implementation of aforementioned programmes in the Veneto region also included the observance of the following principles:

- Principle of regulation quality;
- Principles of subsidiarity, differentiation, adequacy and proportionality;
- Principle of fast administrative action;
- Principle of simplifying and reducing the administrative burdens and burdens borne by citizens and businesses;
- Principle of harmonization and uniformity of administrative procedures;
- Principle of technological innovation in relations between public administration, municipalities and enterprises;
- Principle of accessibility.


On the other hand, RDPs in the Tuscany region use unit costs and lump sums for supported projects that promote vocational training and skills acquisition. The PDR uses three different unit costs for training activities, depending on their duration (less than 20 hours, from 21 to 60 hours, over 60 hours) and a lump sum for coaching activities. Amounts established for unit costs and lump sums are based on the methodologies already developed and used in 2007-2013 and 2014-2020 by the Regional Operational Programme for Competitiveness and Employment, funded by the European Social Fund.

#### Key aspects regarding RDP Veneto

The following table, produced by the European Network for Rural Development (ENRD), presents the main features of Veneto region. Thus, around 4 million people live in this region, but more than 80% of the population live in rural areas and only 1,7% of the VAB comes from the primary sector. The total public expenditure planned for 2014-2020 is 1.194.320.500 euro, with an allocation of 6,36% of national resources for rural development. Funding in the Veneto region comes from 43% of European funds, 40% from the national budget, and 17% from the local budget.

Veneto region has decided to invest in areas such as competitiveness, technological efficiency and organizational modernization to reduce the negative impact of agriculture on the environment. At the same time, at the level of the region, it was chosen to allocate the minimum possible resources for environmental measures and to double funding for Priority 6.




Figure 3. Total public expenditures by investment priority







# The relationship between government and potential beneficiaries

In Ireland, the relations between governmental institutions and clients (including farmers or other types of beneficiaries) are highlighted by a certain "Charter of Rights". The Farmer's Charter of Rights 2015-2020 was agreed upon the discussions with agricultural organizations. This charter also describes the level of service that customers can expect from the Department of Agriculture, Food and Marine Environment (DAFME).

The Farmer's Charter of Rights is complemented by a specific Action Plan detailing how the commitments and standards set out in the Charter are being implemented, as well as other service improvements for beneficiaries to be provided and evaluated by the Department of Agriculture, Food and Marine Environment

In Ireland, in accordance with the Farmer's Charter of Rights and in accordance with EU regulations, the Department of Agriculture, Food and Marine Environment (DAFM) carries out on-the-spot inspections / controls at beneficiary farms under different funding schemes. Usually, the level of the inspection rate is 5%, but in the case of RDP investment measure, it can also reach 20% in the pre-contracting and pre-payment stage, while this rate is 5% in the post-pay phase.

In Veneto, the Veneto Managing Authority has set up an efficient management system to ensure the necessary conditions for achieving the efficacy objectives: delegating to the Paying Agency the process of selecting support requests, monitoring calls, ensuring compliance with predefined times and developing procedural guidelines, e-management of projects over the entire application cycle, regional call planning.

By the act of DGR no. 1937 of 23/12/2015, a multiannual plan for the activation of public procurement procedures was established. The multi-annual plan allows all interested parties to have an adequate

view of the way the programme is implemented and the availability of financial resources. This information allows potential applicants to synchronize the project development process with the evaluation activities and including the process of obtaining the required authorizations and other necessary documents, with planning the implementation of the schemes and related financial commitments and any other activities required in when submitting applications for funding.

In Veneto region, starting January 28, 2016, the submission of RDP funding applications takes place exclusively on-line. Prior to 2016, the user was required to provide documents not only on-line but also original documents (application and annexes).

Consequently, Veneto region accepts the following forms and payment request:

- Signed with digital signature;
- Signed with handwritten signature (transmitted in scanned format);
- Signed with a graphometric signature.

In order to facilitate the process of uploading applications in the on-line environment, a manual dedicated to detailing the procedure for submitting applications online was also distributed. The 24-page manual shows step by step all the procedures for submitting the application, being a specific example of simplifying the procedural flow of funding schemes

#### Leader measure

In Veneto, the area influenced by Leader strategy (D, C and B) covered 328 municipalities (56% of Veneto municipalities) and represents 63% (11.600 km2) of the regional territory and 31% (1.500.000 inhabitants) of Veneto population.

In Veneto, local action groups (LAGs) have an adequate technical structure, composed of representatives of public and private local socio-economic interests, where at the decision-making level neither public authorities nor representatives of other interest groups represents more than 49% of the total number of those entitled to vote. All the actions proposed by the local development strategy must be compatible with the ESI Fund regulatory framework and the current state aid rules. Each level of action therefore certifies the compatibility of the assistance provided by the single strategy, through the required references to the RDP and the applicable regulations (p. 777 of RDP).

In Veneto, in order to ensure an active role for LAGs, from the application submission in the IT system to the relative preliminary assessment, are provided solutions through the managing formulas of LAG-AdG-AVEPA (paying authority).

In particular, based on the experience gained during the 2007-2013 programming period, a Technical Commission for each Local Development Strategy (SDL), chaired by GAL-AVEPA through the LAG representative, is responsible for:

- checking the general situation of the submitted applications;
- verifying and supporting the assessment of aid applications;
- verifying and validating the proposals of the preliminary analysis regarding the the application of the selection criteria;
- preparing the list of eligible applications;

The composition of LAG-AVEPA Technical Commission and the procedures for fulfilling the assigned tasks are defined in the DGR Act approving the LDS.

# Veneto – experience in simplifying primary sector procedures

Through the resolution no. 1932 of 27 July 2010, a working group was created to simplify procedures in the primary sector. The Group has put forward simplification proposals on the procedures for calculating the net income of enterprises and their overall performance in support of certain types of applications and for the recognition of certain certifications or authorizations and to clarify the eligibility of applications in relation to the specific measures of the Programme Veneto Rural Development.

Public and private law issues were identified by regional secretaries and commissioners for their areas of expertise in a consultation where concrete proposals for simplification were presented and illustrated:

- 1. Citizens have made proposals by accessing a special form available on the Veneto Region site;
- 2. Employees of public institutions have submitted suggestions for simplification by accessing a specific form available on the Intranet site of the Veneto region;
- 3. Regional structures have submitted their proposals through institutional channels, at the invitation of the secretaries and regional commissioners in the operational field of each proposed facility.

In total, together with this specific procedures, 868 simplification proposals were collected

Of all these proposals, 26% were accepted, 24% were already implemented, 35% were considered useful, but they were not immediately implemented and therefore postponed and 15% were not accepted, not considered relevant for simplification processes, which in turn are not feasible, taking into account the context or regulatory factors.










#### Figure 13. Public Expenditure Planning at RDP Level - June 2018




Figure 14. Total public expenditure rate in Italy, by region




Figure 15. Total public expenditure rate in Spain, by region









Figure no. 5 The responses provided by beneficiaries regarding the need to request clarifications regarding the information contained in the Applicant / Informative Guide



















Figure no. 10. Distribution of responses provided by beneficiaries on requirements for self-evaluation / pre-scoring of the application form














Figure no. 14 The opinion of NRDP beneficiaries regarding field checks

According to the views expressed by the beneficiaries included in the sample, the complexity of administrative burdens imposed by on-site inspections is generally low and very low (score 1 and 2) or average (score 3). By deepening the analysis on each of the specific aspects of the on-the-spot checks, we note the following:

- The moment when on-site inspections take place is generally very low and low in difficulty • (62,31% of respondents) or an average level of difficulty (22,76%);
- The steps followed by the beneficiaries are low and very low (60,82%) or medium difficulty . levels (24.25%);












Figure no. 19 Difficulties encountered by beneficiaries during different procedural stages


